### A. Members & membership

- A1. Annual Membership Fee to stand at £25.00**
- A2. All members to pay next year annual fees and deposits to the Treasurer by 31st December of the current year.**
- A3. Membership numbers to be capped at 50 members**
- A4. Future Membership capping to be decided and agreed at the AGM**
- A5. Members to advise the Membership Secretary of any changes to their contact details held**
- A6. Any member wishing to resign must inform the Membership Secretary in writing or by Email.**
- A7. The committee may confer Honorary Life Membership on any member of the society deemed to have provided exceptional service in support of the society.  
Honorary Membership status would comprise the following:  
Life membership to the STAGS  
Open invitation to any STAGS event at Members rates.  
Full Member consideration for fully booked events  
Annual invitation to the STAGS AGM event at Guest rates (STAGS subsidy not applicable)  
Full voting rights on any proposition put forward at an AGM**
- A8. Membership applications will be considered as per the guidelines in the Vetting Process for Membership Application (Appendix A)**

### B. Handicaps

- B1. The Handicap Committee shall have sole responsibility for the setting, or changing, of the handicap system, the handicap limits and Society Day points scoring systems.**
- B3. Guests handicaps should be subject to the same criteria as STAGS members when attending STAGS society days. If they are repeat guests please contact the handicap secretary for advice.**
- B4. The members of the handicap committee will be elected in accordance with document - Handicap committee membership vacancy.docx**
- B5. Where deemed appropriate by the Handicap Secretary stableford scores achieved on 'Away days' should be included in a members handicap calculation.  
All signed scorecards from these events should be handed to the Handicap Secretary at the earliest opportunity.**

### C. Society Days and Organisers Responsibilities

**C1. Events will be held once per month between February and November (inclusive) plus a Ryder Cup event in September or October. In the event of the Easter holiday falling on one of these days the event may be moved to the previous Friday.**

**C2. Running Society Days and how they are organised is the sole discretion of that event's organiser.**

**C3. The organiser(s) will inform the Hon. Treasurer of the date and venue and ensure that he sends an appropriate deposit to the golf club concerned.**

**C4. The organiser(s) will inform the membership of the event by e-mail and collate the attendance.**

**C5. Members must advise the organiser(s), at least 10 days before the date of the event, of their intent to play.**

**C6. Members intending to attend a Society Day must transfer their payment electronically, at least 10 days in advance of the event, to the society treasurer who will arrange payment to the relevant golf club.**

**C7. Nominated committee member(s) will be responsible for the provision of 'on the day' prizes for the organiser to award.**

**C9. A member of each group should be nominated by the organiser(s) to act as "marshal" of faster play. Any member not at the tee by their allocated tee time will be 'fined' by having 2 points removed from their on-the-day stableford score. It is the responsibility of any Marshal aware of the latecomer to advise the event organiser of the latecomer. The event organiser will adjust the latecomers score appropriately. If in doubt over a tee shot players must play a provisional ball as they cannot return to replay a tee shot.**

**C13. The treasurer will advise the organiser of the costs, for members and guests at a society day, who will use this to advise attendees.**

### D. Competitions

**D1. A Player of the Year award will be given to both the Winner and the Runner-up based on the best six performances throughout the year.**

**In the event of a tie the winner will be the person with the most 1<sup>st</sup> places followed, if necessary, by the most 2<sup>nd</sup> places and so on until a winner is identified.**

**D2. Player of the Year Points will be allocated to members based on their finishing position at each event.**

**D3. STAGS Credits will be awarded to the Winner (£55), Runner up (£30), 3<sup>rd</sup> Place (£20) and any Hole-in-One achieved (£25 and a trophy to be purchased in time for presentation at the next society day), by a STAGS member, at each society day. The winner will receive a trophy.**

**A winning Guest prize, of a bottle of wine, may be issued at the discretion of the organiser(s).**

**D4. Six prizes of a bottle of wine will be issued on each society day for any nearest the pin/longest drive, as deemed appropriate by the organiser. This prize category is open to both STAGS members and Guests. The nominated committee member will provide the wine to the organisers for presentation on the day.**

**D5. In the event of a tie the count-back process will be used to ascertain 1<sup>st</sup> and 2<sup>nd</sup> places.**

**Count-back is calculated by taking the best score on course holes 10 to 18, then holes 13 to 18, then holes 16 to 18, 17 to 18 regardless of the hole on which the players started their round.**

**D7. Singles Knock-Out games may be played on Society days if an alternative date cannot be arranged.**

**D8. The Ryder Cup captain is responsible for the selection of the vice captain who will take over as Ryder Cup Captain in the following year.**

**D9. Entry to the Singles, Doubles or Ryder Cup competition is voluntary. Members should opt out when the invitation to take part is circulated.**

**D10. The competition Secretary is responsible for making all decisions around STAGS competitions – When they are held, the rules and scoring system which will be applied and any other issue associated with the competition.**

### **APPENDIX A: Membership Application Process**

This process will be followed for all new membership applications received after the above date to ensure that the applicant will be a suitable addition to the STAGS society.

Anyone wishing to become a member of the STAGS will complete a membership application form and send it to the Membership Secretary who will forward this onto the Committee. The Membership Secretary will then monitor progress through this process until conclusion.

All applicants must complete three qualifying rounds with the STAGS as a guest. If the applicant has played with the STAGS as a guest in the twelve months prior to submitting their application, then a maximum of two of these rounds may count towards this qualifying total. One or more (so as to achieve the three) qualifying rounds must therefore be played by the applicant with us as a guest in the twelve months following the date of their application.

Use of guest appearances from the twelve month window prior to applying is acceptable so long as scorecards for those occasions were available for scrutiny by our Handicap Secretary.

A qualifying round is one where the STAGS play a Stableford scoring system and not any other system such as match play or another style of competition. At least one of these should be where the applicant plays with a STAGS Committee Member. This is so the applicant's handicap can be evaluated under the same scoring system as we play on a regular society day and so that their playing etiquette can be confirmed.

Failure to complete the three qualifying guest rounds within the specified time period will nullify the application.

The applicant's proposer or seconder should ensure that invitations to STAGS society days are forwarded to the applicant until such time as their application is decided.

On completion of the three qualifying rounds, reports received as to the applicant's playing etiquette will be made to the STAGS Committee for consideration in the final decision on the success of the application.

The applicant's performance in the three qualifying rounds will be used by the Handicap Secretary to assess the new member's starting handicap within the society.

The Membership Secretary will inform the applicant of the Committee's decision.

A successful applicant will be asked to pay the annual membership fee, deposits for the remaining society days for the year and the cost to purchase their STAGS shirts.
